

TERMS AND CONDITIONS Law 1556 Application System

Please carefully read the following terms and conditions, which govern the use of the application system of the Ley 1556 of 2012 (the 'application system'), part of the website www.locationcolombia.com.

Proimágenes, through the Colombian Film Commission is an entity responsible for receive the application of the projects interested in apply to the incentives of the law 1556 of 2012, following the condition define in the Resource Allocation Manual. Through this application system, Proimágenes receives projects for evaluation.

Proceeding

For the end previously described, Proimágenes has established the following conditions for the application system:

The user interested in applying must be the producer of the audiovisual project.

As a requirement to apply, is mandatory to read and fully accept these terms of conditions as well as the privacy notice provided by Proimágenes.

When doing this registration, the user declares under oath that all information provided is true and verifiable. The information provided is done freely, taking into account that will follow the procedures define for the incentives addressed in the Law 1556 of 2012.

The procedure to be registered in the directory includes the following steps:

Register <u>here</u> and create a user from which the application process will be made. The user will receive confirmation via email.

Once all the requirements are fulfilled the user can apply or the system will show which information is missing. The user can also save the information while completing it. Only the applied projects will be reviewed.

Once the application is done the user will receive confirmation via email. The entity in charge will have a period of 10 days for its corresponding revisión. In case of require additional information, the entity will contact the user. Once the information is complete, the project will presented to the Colombian Film Promotion Committee for approval or disapproval, the user will be informed of the decision.
